

The need for Spanish-speaking child care providers in the Douglas County area is growing tremendously. Today, 6.7% of the county's GENERAL Douglas County population is of Hispanic descent. The Hispanic 0-4 population is growing even more rapidly, and comprises 12% of that age population. That's approximately 4,000 Hispanic children, many of which are receiving child care in family child care homes and child care centers.

This project was developed through a partnership between the *Nebraska Association for the Education of Young Children/T.E.A.C.H. Early Childhood® NEBRASKA* and *Metropolitan Community College*. The goals of this project are to improve the quality of early care and education through education, compensation and continuity.

This project is funded through the T.E.A.C.H. Early Childhood® Nebraska contract with the Nebraska Department of Education with funds from the Department of Health and Human Services Child Care Development Funds, and with support from The Head Start State Collaboration Office and private foundations.

**The T.E.A.C.H. Early Childhood® NEBRASKA project provides:**

- 80% of the costs of tuition and books
- \$60 per term for travel for students
- pay for release time to the centers to help with the cost of substitute care
- a bonus of \$350 at the end of the contract year for the student

**The centers agree:**

- to pay 10% of the cost of tuition and books
- to provide the release time
- to provide either a 2% salary increase or a matching bonus at the end of the contract year for the student

**The students agree:**

- to take at least 12 credits in a 12 month period
- to earn at least a C
- to pay 10% of the costs of tuition and books
- to remain with their facility for a year after the completion of the T.E.A.C.H. contract, thus reducing the staff turnover
