

Scholarship Opportunities for Child Care Providers



Improving the quality of child care in NEBRASKA by increasing the education, compensation, and stability of the early childhood workforce.



All scholarships are a partnership between T.E.A.C.H., the scholarship recipient, and their sponsoring child care program.

Scholarship Recipient Responsibilities:

- Attend classes and successfully complete the minimum contract requirements.
- Pay a portion of the cost for tuition and books.
- Agree to remain with your sponsoring employer or operate your family child care program for one year (18 months for Bachelor Degree) after completion of each contract.
- Communicate regularly with T.E.A.C.H. concerning your education and employment.

Sponsoring Program Responsibilities:

- Pay a portion of the cost of tuition and books.
- Give the recipient paid time off (release time) from work each week to attend classes or study. (T.E.A.C.H. Early Childhood® NEBRASKA reimburses a portion of the cost.)
- Award the recipient a bonus or a raise upon completion of the contract requirements.
- Communicate regularly with the sponsored student and T.E.A.C.H. concerning their education and employment.

Scholarships available for Associate's and Bachelor's Degrees

To be eligible to receive a scholarship you must:

- Work in a licensed family child care home, child care program, preschool or Head Start.
- Work 30 hours per week or more.
- Earn less than \$17.50 per hour.

**Additional criteria may apply.*

T.E.A.C.H. Provides:

- ❑ 80% of the cost of tuition and books.
- ❑ A travel stipend each term.
- ❑ \$\$ for hiring a substitute and/or paid time off work to study, go to school, etc.
- ❑ A bonus at the end of a contract period.
- ❑ College and career support and assistance.
