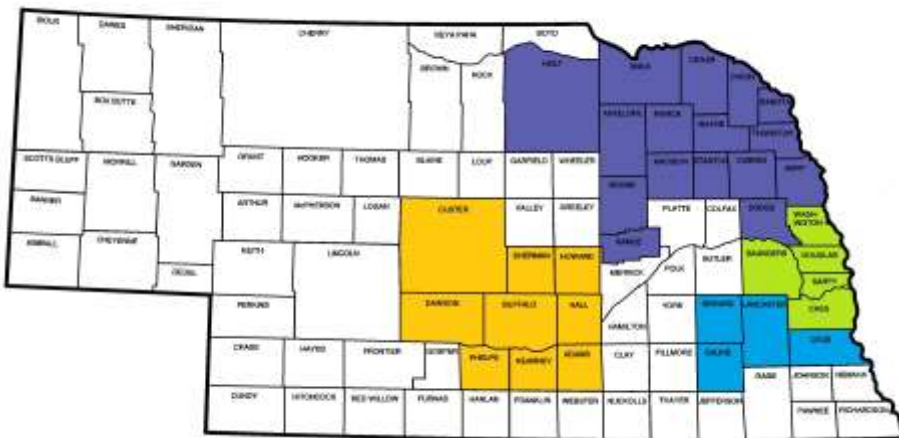
Nebraska AEYC is an affiliate of the National Association for the Education of Young Children (NAEYC). The NAEYC Affiliate Network is a vibrant community of nonprofit organizations dedicated to providing local member engagement opportunities, resources, conferences, professional development, and advocacy efforts for our shared members.



This past year, NAEYC engaged the early childhood community in exciting initiatives and provided valuable resources, including a new Power to the Profession website (<http://powertotheprofession.org/>), the release of the Unifying Framework for the Early Childhood Education Profession (<https://www.naeyc.org/our-work/initiatives/profession>), and the release of the Advancing Equity Position Statement (<https://www.naeyc.org/our-work/initiatives/equity>).

Membership

In the 2019-2020 fiscal year, Nebraska AEYC had an average of 361 members between our four chapters and at-large counties with a peak in December 2019 with 379 members. Throughout the year, we welcomed 90 new members and had an average retention rate of 48.05%.

EarlyEdU

Nebraska AEYC, Nebraska Department of Education–Office of Early Childhood, University of NE at Kearney, and Buffet Early Childhood Institute partnered together to deliver a set of three EarlyEdU courses to early childhood educators in Nebraska at a very low cost. During the Fall 2020 semester, a cohort of early childhood educators completed the final class in this set of competency-based online coursework. Even though these EarlyEdU courses will no longer be offered, four of the nine EarlyEdU participants have continued on with their education using an associate degree or bachelor degree scholarship with the T.E.A.C.H. Early Childhood® NEBRASKA scholarship program.

Child Care WAGES® NEBRASKA Family Child Care Pilot
Child Care WAGES® NEBRASKA is a program that provides education-based salary supplements (sometimes called stipends) to low-paid early care and education providers working with children ages birth-five in licensed family child care settings in Nebraska.

WAGES impacts early childhood education programs and educators by...

- ① Recognizing and rewarding dedicated professionals
- ② Stabilizing the early childhood workforce
- ③ Encouraging continued education

- ◇ 18 child care professionals earned salary supplements.
- ◇ 145 Nebraska children benefited from consistent care provided by a WAGES participant.

Education

- ◇ 67% of participants had an Associate Degree in Early Childhood Education or higher OR submitted education documentation to show progress in college.

Compensation

- ◇ 50% of WAGES participants earned less than \$12 per hour
- ◇ Recipients earned an average six-month supplement of \$1,088

Retention

- ◇ 100% of WAGES participants stayed in their early education programs.

Demographics

- ◇ 6% of participants were people of color
- ◇ 100% of participants were women

Rooted in Relationships

The Lancaster County Rooted in Relationships initiative included 23 providers, 12 center directors, and directly impacted 231 children in Lincoln.

The Rooted in Relationships project offers the following activities to support the implementation of the Pyramid Model:

- On-going professional development,
- Individualized coaching for providers and center directors,
- Individual child assessments,
- Opportunities for community collaboration activities, and
- Access to grants for additional materials.



Circle of Security-Parenting (COS-P)

COS-P is an **8-week parenting program, designed to help parents learn how to respond to their children's needs in a way that enhances the parent/child connection, which often leads to changes in the child's behavior.**

Nebraska AEYC has multiple grants to facilitate COS-P classes across the state including:

NDHHS Referred Families: 155 referred parents completed a class

Community Healthy Endowment: 5 classes

Nebraska Child Abuse Prevention Fund: 15 classes

Nebraska Children and Families Foundation: 2 classes

Parents Interacting With Infants (PIWI)

PIWI is an evidenced-based set of practices based on beliefs (a “philosophy”) about families, children, and helping relationships. The objectives of PIWI are to increase confidence, competence, and positive relationships for parents and children ages 0-2. It does so by keeping the parent-child relationship at the center and by supporting responsive, respectful parent-child interactions. Nebraska AEYC received a grant from the Nebraska Child Abuse Prevention Fund to support the delivery of PIWI in Lincoln. Two newly trained PIWI facilitators began their first class in the spring of 2020, but due to COVID, had to postpone the completion of the class until fall of 2020.

Parent-Child Interaction Therapy (PCIT)

PCIT is a treatment model for children ages 2 to 7 that places emphasis on improving the quality of the parent-child relationship and changing parent-child interaction patterns. In PCIT, parents are taught specific skills to **establish a nurturing and secure relationship with their child while increasing their child's pro-social behavior and decreasing negative behavior.**

Nebraska AEYC received a grant from the Nebraska Child Abuse Prevention Fund to support the delivery of PCIT in Lincoln. A therapist was selected to attend PCIT training in the spring of 2020, but due to COVID, that training was completed in the fall of 2020. Funds from the grant will also support the purchase of materials and supplies that will allow PCIT-trained therapists to carry our PCIT to fidelity.



Infant/Toddler Quality Initiative

The Infant/Toddler Quality Initiative (ITQI) works in collaboration with the Community Action Partnership of Lancaster and Saunders Counties and the Nebraska Department of Health and Human Services. This project offers an opportunity for child care providers, serving infants and toddlers, to increase the quality of care and early education offered to these youngest learners.

The Infant/Toddler Quality Initiative (ITQI) completed its most unique year yet. Despite the challenges of closures, furloughs, and as a result of utilizing lots of flexibility, eight classroom teachers and one family child care provider finished strong. Coaching throughout the Initiative looked different for each provider based on the individual circumstance, but all participated through emails, texts, and Zoom. The outcomes shifted to a focus on relationships with teachers prioritizing the social and emotional needs of children. Teachers were then able to enhance materials in the classroom with the benefit of the resources provided through the ITQI. Recognizing the additional need for children to experience consistency, observations demonstrated an average increase of over one point in the category of Program Structure. Also trending significantly in the positive was the category of Activities, a result of a lot of intentionality and resourcefulness by the providers. By utilizing the benefits of this project as well as coaching, providers were able to overcome the limitations set forth by COVID regarding the use of several types of classroom materials. By modifying the outlook and expectations, ITQI was able to have a successful year.



Nebraska AEYC Leadership Academy

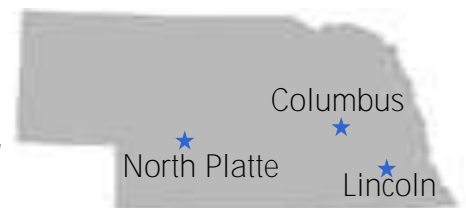
Fourteen early childhood professionals across Nebraska, including center directors in Lincoln and Columbus, as well as family child care providers in **North Platte, completed the Leadership Academy's 2019-2020 session.**

Each cohort met monthly and discussed topics such as: Authentic Leadership, Core Values, Emotional Intelligence, Active Listening, Strengths Based Leadership, and Leadership in Early Childhood.

Each month, participants completed several self-assessments and discussed results together. It certainly was a unique year, as participants were unable to meet in person the last half of the year, instead meeting virtually. Participants took the changes in stride and smoothly transitioned to the new format.

In 2019-2020, the Leadership Academy was supported by the Nebraska Department of Health and Human Services. This allowed the service of five center directors in Lincoln, five in Columbus, and four family child care providers in North Platte.

United Way Quality Enhancement Project (QEP)

In partnership with the United Way, Nebraska AEYC is working with one child care center in Lincoln to improve the quality of care in two preschool classrooms. This project uses a combination of activities and resources to produce a measurable increase in the quality of care being provided to children including pre- and post-ECERS assessments, regular coaching, purchasing additional classroom materials, and professional development activities. Specifically, through the coaching partnership model, we work with both the teachers in the classrooms and the director of the program. The coach, teacher, and director use the results of the pre-assessment as a foundation for classroom improvements. As we continue through this project, a post-classroom observation will be completed and shared with the teachers and director. The results of the classroom observation provide a detailed account of where improvements were made, and where future goals may be determined.



Recognition

This year, Gina Sandoz and Penny Gildea received the 2020 Nebraska AEYC Distinguished Service to Children Award. This award was developed in 1983 to recognize a Nebraska AEYC member who has contributed outstanding service to the organization, its program of work, development, and membership; or a Nebraskan who has done exemplary work to promote the rights, services, status, and programs for/of children.
